ORDER

The Assam Council of Medical Registration, in its Council meeting, held on 8th July, 2024, after due enquiry found that Dr. Mridu Paban Nath was unauthorizedly absent from his duty at Diphu Medical College, Diphu since 1st May, 2024 which had affected the service to the patients of the Hospital, both under regular as well as Emergency care, since his service as an Anaesthesiologist is of utmost importance in patient care. This action of Dr. Mridu Paban Nath is felt by the Council as violation of Code of Medical Ethics mentioned in the chapter I of Indian Medical Council (Professional Conduct, Etiquette and Ethics) Regulations, 2002. Under these circumstances the Council decided to remove the name from the register of Dr. Mridu Paban Nath for a period of Six (6) months as empowered by section 23(1) of the Assam Medical Council Act, 1999. He is also directed to handover all Registration Certificates of Assam Council of Medical Registration to the Registrar, Assam Council of Medical Registration, Sixmile, Guwahati-22 within 7 (seven) days from the date of issue of this order. However, he will be at liberty to appeal against the decision of the Council before the Assam Govt as mentioned in section 25 of Assam Medical Council Act, 1999 (Amended up to 2014) or before the Ethics and Medical Registration Board of National Medical Commission as mentioned in section 30 (3) of the National Medical Commission Act, 2019.

The name of Dr. Mridu Paban Nath, whose Registration no is 15177 dated 08/09/2000 is hence removed from the Register of Assam Council of Medical Registration for a period of six months with effect from the date of issue of this order.

Dr. Mridu Paban Nath is therefore directed to submit the Original Copies of the Registration Certificates within 7 (seven) days from the date of issue of this Order at the Office of the Assam Council of Medical Registration, Sixmile, Khanapara, Guwahati-22.
